\_\_\_\_\_ I agree to provide an NCFPP representative access to all parts of my home and property for a home inspection before my application to foster is approved.

\_\_\_\_\_ I understand that I may be required to provide foster car to my foster animal for an extended an indefinite period of time.

\_\_\_\_\_ I agree that I am over the age of 21.

\_\_\_\_\_ I understand that NCFPP provides no guarantee as to the health of my foster animal and that my foster animal may have medical needs, socialization problems and may not be housebroken.

\_\_\_\_\_ I agree to provide my foster animal with veterinary care as authorized by NCFPP. I will not arrange or pay for any elective veterinary care for my foster animal without the express consent of an authorized NCFPP representative.

- \_\_\_\_\_ I will take all necessary precautions to prevent my foster animal from either impregnating another animal or becoming impregnated. In the event that happens, I will notify NCFPP immediately.
- \_\_\_\_\_ I understand that I may only have my foster animal temporarily.
- \_\_\_\_\_ I agree that I am fostering this animal for NCFPP and that I do not have any right of ownership over my foster animal.
- \_\_\_\_\_ I agree to provide any representative of NCFPP with access to my home and property to check on my foster animal, at any time that I am in possession of my foster animal.
- \_\_\_\_\_ I agree to immediately, at any time and for any reason, return any foster animal in my care to NCFPP at the request of an authorized representative of NCFPP. If NCFPP is forced to undertake a legal action to enforce this provision of the agreement, I agree to indemnify NCFPP for all court costs and attorney's fees connected with such an action.
- \_\_\_\_\_ If I am planning to move at any time during the period when I am housing a foster animal, I agree to contact NCFPP prior to my move and provide NCFPP with my new contact information. I understand that NCFPP has the right to request return of my foster animal based on my change of residence, and agree that I will surrender my foster animal to NCFPP immediately upon request.
- \_\_\_\_\_ I understand that as long as I provide foster care to my foster animal to NCFPP's satisfaction, I will be given the first right of adoption of my foster animal, at such time as NCFPP decides to place my foster animal for adoption.
- \_\_\_\_\_ If at any point I can no longer, or do not want to continue to, provide care and shelter for my foster animal, I agree to contact NCFPP and arrange for surrender and return of my foster animal and any items belonging to NCFPP to NCFPP immediately.
- \_\_\_\_\_ I will not transfer possession or custody of my foster animal to any other person at any time, unless authorized by a representative of NCFPP.
- \_\_\_\_\_ I agree that if I refuse or fail to comply with any provision of this agreement, NCFPP has the right to terminate this agreement and also has the right to the

immediate surrender and return of my foster animal. I further consent to provide NCFFP access to my premises, if necessary, to facilitate that return.

\_\_\_\_\_ I agree to transport my foster animal to and from the groomer, veterinarian, adoption centers or other locations as requested by an authorized representative of NCFFP.
